ASWB Path to Licensure Institute

The ASWB Path to Licensure program is pleased to announce a new ASWB Path to Licensure Institute for social work educators.

The Path to Licensure program is a collaboration of educators, practitioners, and regulators encouraging and supporting students' professional development journey. It builds a bridge of understanding so professional regulation is embraced as an essential component of the profession and is a clear component of the competencies that educators teach. Professional regulation establishes minimum standards of competence to become and remain licensed and plays a critical role in public protection and in ensuring high standards for safe and competent professional practice.

The **ASWB Path to Licensure Institute** is a bold twofold initiative:

- Scholars implement a Path to Licensure program during the coming school year
- Scholars complete social work regulation-specific research

The institute begins with three days of intensive learning, planning, and research May 23–25, 2017, at the ASWB offices in Culpeper, Virginia. Each scholar will implement a Path to Licensure plan during the 2017-2018 school year. Each scholar will conduct research on a social work regulatory topic as approved by ASWB and submit it to ASWB by no later than August 2020.

Path to Licensure Institute scholars work with ASWB leadership and institute faculty consultants. The consultants are:

- Deana F. Morrow, Ph.D., LCSW, LISW-CP, ACSW, chair of the department of social work at Winthrop University, Rock Hill, South Carolina
- Dorinda Noble, Ph.D., LCSW, former director of the school of social work at Texas State University, San Marcos, Texas

The ASWB Path to Licensure Institute seeks a diverse group of six social work faculty who bring expertise from many academic disciplines and organizational specialties and a range of ethnic and national groups, ages, and years of experience in higher education and other related fields.

Each scholar will receive a \$2,500 stipend to cover travel and personal expenses. Lodging for the three-day intensive will be provided at the Holiday Inn near the ASWB offices in Culpeper, Virginia.

Scholar Preparation

In order to prepare for participation in the three-day intensive, scholars will complete the following before arrival on May 22, 2017:

- 1. Administer a survey to social work faculty at your school and compile the results. The survey will be sent with the acceptance notification.
- 2. Familiarize yourself with the websites of ASWB (www.aswb.org) and your state licensing board.
- 3. Attend, if possible, a meeting of the licensing board in your state.
- 4. Study reading materials that will be sent to you with your acceptance notification.
