Appointed by the ASWB president, this group of subject matter experts meets up to four times a year to review and approve test questions for use on the ASWB examinations. Examination Committee members are appointed from among ASWB item writers.

## PRACTICE ANALYSIS WRAPUP AND NEW EXAM CREATION

ASWB's analysis of the practice of social work, conducted every five to seven years, is the cornerstone of the social work licensing exam program. During the 2017 examination program year, ASWB staff and volunteers completed activities associated with the most recent analysis process, setting the stage for new examination blueprints that will debut in early 2018.

Accomplishments included:

- Reclassification of examination items to match the new blueprints
- Successful standard setting meeting to establish passing scores for each examination category
- Publication of a technical report on the practice analysis
- Development of new online practice tests to match the new blueprints, including revised rationales for each item
- Updates to the ASWB Guide to the Social Work Exams

These accomplishments were achieved while ASWB continued to maintain the current examinations: writing and reviewing test items, reviewing examination forms, and conducting problem item review, among other activities. Additionally, 2017 marked the launch of a new, proprietary item development software that will allow the association to move its test questions through a seamless system that streamlines the development process and increases security.
