Board of Directors

The following skills, qualifications, and experience are helpful in fulfilling the duties of positions on the Board of Directors. In addition, the Nominating Committee will take a variety of factors into consideration when populating the slate including geographic, gender, and ethnic diversity.

- Familiarity with the ASWB governance process
- Jurisdictional board service experience
- Service on other nonprofit boards
- Awareness of policy development
- Attendance at an ASWB Annual Meeting of the Delegate Assembly
- Understanding of and experience with ASWB as an organization
- Understanding and experience in leadership roles
- Familiarity with Roberts Rules of Order and/or process of meeting management
- Ability to work comfortably in a consensus model of decision-making
- Knowledge of ASWB programs (ACE, Examination, Registry, etc.)
- Ability to understand nonprofit financial practices

Individuals currently serving on the ASWB Board of Directors in a term that extends beyond the 2022 elections are *ineligible*. All candidates who are licensed professionals must maintain licensure in good standing throughout their term of service.
